Thank you for your continued support as your SGEU negotiating committee works towards reaching a fair and reasonable agreement for our SGEU Health Provider members.

Bargaining dates

Your negotiating committee met with the Saskatchewan Association of Health Organizations (SAHO) and the Saskatchewan Health Authority (SHA) from September 10 to 12 and again from November 19 to 21 in Saskatoon. Due to the provincial election being called, we were unable to schedule bargaining dates in October.

Negotiations have been progressing slowly because SAHO has only one negotiating committee that must divide its time between SGEU, CUPE and SEIU-West.

Future bargaining dates have been scheduled for January 7 to 9 and February 19 to 21, 2025.

Updates from bargaining meetings

Employer proposals

The SHA has designed their proposals around existing networks that would allow them to move members across workplaces and union boundaries without notice. That means a member might go to work and find out they have to work 30 to 50 km away. Your negotiating committee is not in favour of this.

SAHO's proposal package includes several changes that would significantly alter your collective agreement as it stands today. Your negotiating committee is committed to ensuring that we maintain our current language and, and we continue to communicate to SAHO that we have no desire to have one common collective agreement amongst the provider unions. To date, there has been no conversation regarding monetary terms.
